## **SECTION B**

A NOTARY IS PERSONABLY LIABLE FOR THE FULL AMOUNT OF DAMAGES CAUSED AS A RESULT OF MISCONDUCT IN PERFORMING A NOTARIAL ACT.

WHAT IS ERRORS & OMISSIONS INSURANCE? CAN YOU AFFORD TO BE WITHOUT IT?

IT IS A COMMON MISUNDERSTANDING AMONG NOTARIES THAT THEY ARE PROTECTED FROM CIVIL LAWSUITS.

THIS IS INCORRECT.

ERRORS AND OMISSIONS INSURANCE IS A FORM OF PROTECTION PROVIDED FOR NOTARIES BY ABSORBING THE COSTS OF A LAWSUIT RESULTING FROM THE NOTARY'S UNINTENTIONAL ERROR OR HAVING A GROUNDLESS LAWSUIT LEGALLY DISMISSED. IN MOST CASES, IF THE NOTARY IS SUED AS A RESULT OF HIS ACTIONS, THE ERRORS AND OMISSIONS INSURANCE WILL TAKE OVER THE DEFENSE OF THE LAWSUIT AND PAY ATTORNEY FEES AND A JUDGMENT UP TO THE AMOUNT OF THE POLICY LIMITS. NOTARIAL ACTS THAT ARE DISHONEST, FRAUDULENT OR ILLEGAL ARE NOT USUALLY COVERED BY ERRORS AND OMISSIONS INSURANCE.

MANY PEOPLE FEEL THEY ARE COVERED UNDER THEIR GENERAL LIABILITY INSURANCE POLICY. YOU SHOULD CHECK IT OUT AS MOST GENERAL LIABILITY INSURANCE POLICIES SPECIFICALLY EXCLUDE NOTARIAL ACTS.

YOU'VE UNDOUBTEDLY PROTECTED YOUR PERSONAL EFFECTS FROM CERTAIN THREATS WITH OTHER TYPES OF INSURANCE SUCH AS CAR INSURANCE, AND HOMEOWNERS/RENTERS INSURANCE. DON'T NEGLECT TO PROTECT YOUR NOTARIAL ACTS WITH NOTARY PUBLIC ERRORS AND OMISSIONS INSURANCE. THE TERM OF THE POLICY IS THE SAME AS YOUR COMMISSION. POLICIES MAY BE PURCHASED AT A NOMINAL PREMIUM WITH VARIOUS LIMITS. DON'T WAIT. PROTECT YOURSELF AND THOSE WHO DEPEND ON YOU... NOW!
