To apply for your commission, you must obtain a new notary bond in the amount of one thousand dollars. (\$1,000) for new four year term. If you work for a *Governmental Agency* and you may be notarizing outside of the workplace you must obtain a Notary Bond in the amount of one thousand dollars (\$1000) for the new four year term.

The State of Alaska does not require you to obtain a new seal or notarial marking device when you apply for your commission. However if you should wish to change the type of seals that you presently have, we can provide those. The state handbook also suggests a 'My Commission expires' with your name on it which we can also provide.

We also have errors and omissions insurance available for notaries which is a policy that is designed especially for the notaries' own personal protection. This is an E&O policy this is designed especially for notaries which should not be confused with a Notary bond, which does not protect you.

4. After you have signed your bond and completed the test (if applicable) you will send those with completed state application along with a check for \$40.00 made payable to the State of Alaska.

5. Forward your new license via email, fax or mail to LMI Notary Service so we may produce your stamp and supplies
