1. Complete and return the original application with payment (check or credit card) in the amount to be determined by your selection
2. Complete the enclosed *Application for Appointment as a Notary Public* and *Notary Bond* form (the state of Idaho requires that original forms are filed)
3. Complete your Notary Bond by signing the by the "X" as Principal
4. Mail the originals to LMI Notary Services
5. Receive your **Certificate of Reappointment** from the state
