Your Notary Public License is up for renewal. To renew your commission, you must obtain a new notary bond in the amount of ten thousand dollars. (\$10,000) for your four year term

The State of Nevada requires you to obtain a new inked stamp that says "State of Nevada Notary Public", your Name, and date of expiration and number of your certificate. We can provide you with a stamp by making your selection below, as well as a logbook to record your notarizations.

- 3. On receipt we will create and send your new four year Notary Bond to you to sign in a designated area.
- 4. After you have signed your bond take it to the county clerk in which you reside and have the oath administered and filed.
- 5. We will provide you with the state renewal application for you to complete sections 1-17
- 6. Complete the STATE REQUIRED Notary Training Class –http://www.nvsos.gov/sos/licensing/notary/training-class-information You can do this class online or in person
- **7.** File your state 'Application for Appointment' along with your 'Filing Notice' from the clerk, and your training class certificate, and a check for \$35.00 to the Secretary of State
- 8. Forward your new license via email, fax or mail to LMI Notary Service so we may produce your stamp and supplies
