**To renew a commission you must obtain a notary bond in the amount of ten thousand dollars. (\$10,000) for your four year term.**

The State of Texas requires you to obtain a new notarial marking device when you apply for your commission, which we can provide .

We also have Errors and Omissions insurance available for notaries which is a policy that is designed especially for the notaries' own personal protection. This is an E&O policy that is designed especially for notaries which should not be confused with a Notary bond, which does not protect you.

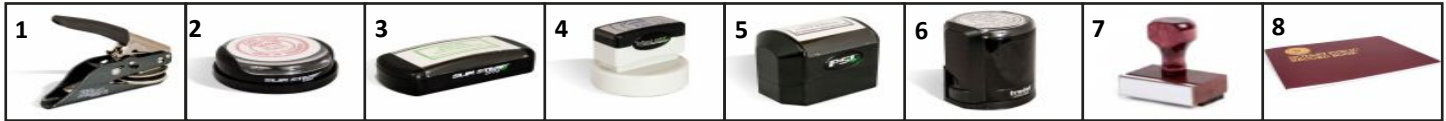
